Our Criminal Background Policy

Rental Application ("Application") will be denied when conviction of misdemeanor or felony for acts of:

- Violence
- Sexual offenses
- Harm to persons or to property

establish a pattern of behavior that poses a clear and present threat to the health and safety of:

- Other residents
- Other individuals
- The housing community at large
- The dwelling unit itself

A clear and present threat will be established by the:

- Severity of the offenses,
- Number of offenses,
- Length of time the offense occurred from the time of Application.

Conviction of misdemeanor or felony where time has been served within five (5) years of Application will be basis for denial.

Convictions of Class One (1) felonies for violent crimes resulting in five (5) or more years of time served within ten (10) years of Application will be basis for denial.

Deposit Policy:

A deposit of \$750.00 is required to hold an apartment upon application approval. Available units are first come, first served and are removed from the list above once a deposit has been received from an approved applicant. If you are unable to take the apartment you will lose a minimum of \$100.00 and up to the entire deposit depending on how long the apartment has been held. You must take possession of the apartment within fifteen (15) days of it being made ready for move-in.
